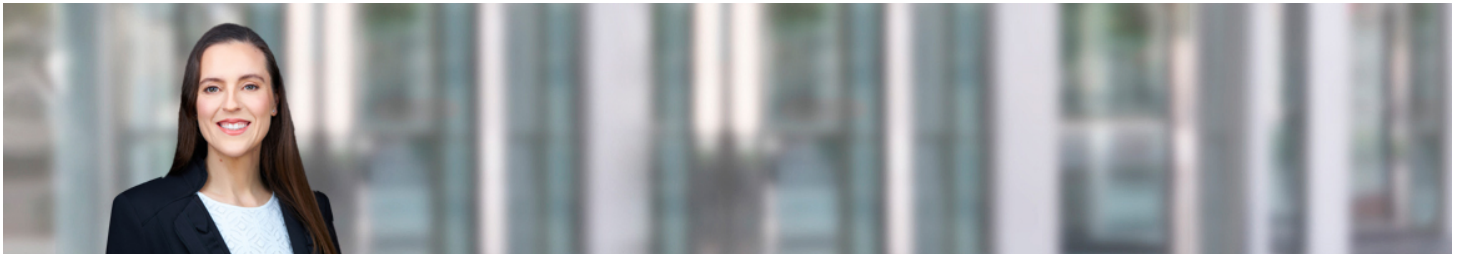

OVERVIEW
