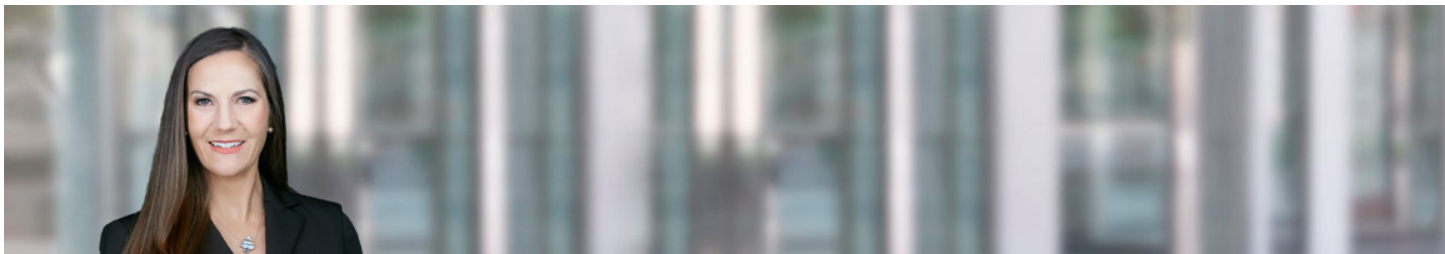

### OVERVIEW
