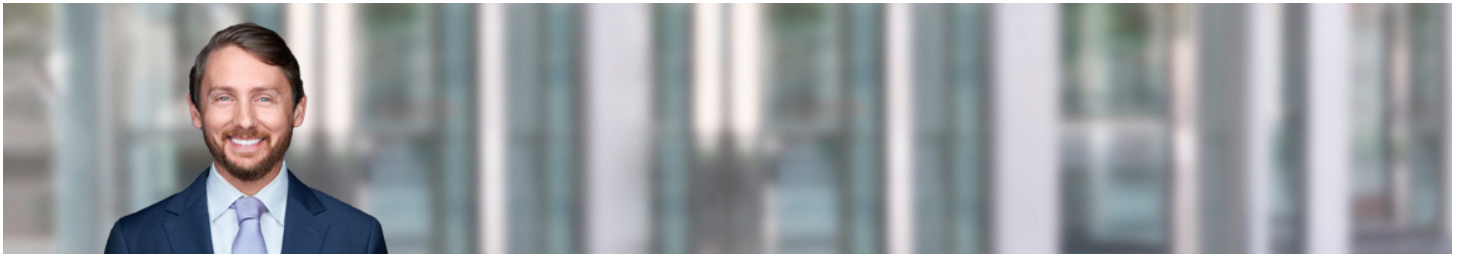

OVERVIEW

Ryan Thornton is a Shareholder in the Litigation Department. His practice focuses on complex litigation matters at the trial and appellate levels in both state and federal court. Ryan's experience includes representing public and private companies in a variety of contract and business tort disputes, as well as class action litigation.

Ryan clerked for The Honorable Federico A. Moreno of the United States District Court for the Southern District of Florida. Prior to joining the Firm, Ryan was a law clerk for the New York office of an international firm, and an intern for The Honorable Cecilia M. Altonaga of the United States District Court for the Southern District of Florida. During law school, Ryan interned for the United States Department of Justice in its Criminal Division's Fraud Section.

Ryan earned his J.D., *cum laude*, from Georgetown University Law Center and his B.A., *magna cum laude*, from Duke University.

REPRESENTATIVE EXPERIENCE

Successfully represented the iconic Ball & Chain and Taquerias El Mexicano/Los Altos, affiliated with The Mad Room LLC, a Hospitality management company, in a federal suit against the City of Miami alleging violations of substantive and procedural due process, equal protection, unlawful searches and seizures, as well as other constitutional law violations. These were issues of first impression against a prominent municipality where the City developed and deployed a deliberate policy to abolish client's fundamental protected rights to their property. Ultimately, the City of Miami Commission approved a \$12.5 million payout (along with non-monetary benefits) to our clients. Assisted with parallel lawsuit that secured a \$63.5 million jury verdict against City commissioner for the political vendetta predicated the City's unlawful policies.

Represented Class consisting of 179 real estate investors, resulting in a \$100 million settlement. The settlement resolved claims that one of the largest commercial real estate firms in the world, and one of its employees, concealed and failed to alert our clients to an on-going multi-million dollar embezzlement scheme.

Represented Robinhood Markets and affiliates as Florida counsel in putative consumer class action based on an alleged failure to prevent customers from placing trades for securities subject to a trading halt. The district court denied class certification.

Represented Robinhood Markets and affiliates as Florida counsel in putative securities class action based on an alleged breach of a broker's duty of best execution, successfully obtaining transfer of the action to the Northern District of California.

Represented All Aboard Florida (now Brightline) entities in miscellaneous state and federal actions asserting administrative and regulatory claims. These proceedings have been resolved favorably through litigation or agreement.

Represented food subscription service and real estate brokerage in defense of putative class actions brought under the recently-enacted Florida's Telephone Solicitation Act. Each case settled on favorable terms.

Represented start-up company in enforcement of restrictive covenants against former partner, resulting in favorable business divorce.

Represented owner of car dealership in action seeking judicial dissolution under the Florida Revised Florida LLC Act and alleging breach of contract and breach of fiduciary duties against co-owners, resulting in settlement on favorable terms for the client.

Represented regional bank in civil suits in federal and state court arising from bank's alleged involvement in Ponzi scheme. Each case ultimately settled upon favorable terms for the client.
